## 4. GENERAL SERVICE REQUIREMENTS

- 1. The only purpose of this document is to provide information to the interested parties that may be useful to them in the formulation of their proposal pursuant to this document.
- 2. CAU will not have any liability to any prospective Applicant/ Firm/ or any other person under any laws for any loss, expense or damage which may arise from or be incurred or suffered in connection with anything contained in this document.
- 3. The Empanelment procedure will not be vitiated/ cancelled for want of specific number of offers to be received against the RFP.
- 4. Cricket Association of Uttarakhand, Dehradun (CAU) reserves the right to withhold or withdraw the process at any stage or accept/reject any or all of proposals at any stage without assigning any reasons whatsoever and no appeal, objection or communication will be entertained from any applicant/ offerer.
- 5. CAU reserves the right to demand any additional document/ declaration/ evidence etc. from the offers/ applicant to ascertain the requirements of selection.
- 7. The applicant can submit proposal either for Taxi or Bus (any one) **OR** for both (Taxi & Bus) in a sealed envelope. All the pages of the financial proposal shall be duly signed by the authorized signatory of the Agency in ink before submission. Corrections, if any, shall be countersigned. Failure to provide and/or comply with the required information, instructions, etc. incorporated in the documents may result in rejection of his proposal.
- 8. The Empanelment period will be initially for a period of one year and will be further extendable, on mutual consent of both parties on satisfactory performance on yearly basis.
- 9. In the event of any dispute or difference(s) between the CAU and the Vendor(s) arising out of non-supply of material or supplies not found according to specifications or any other cause whatsoever relating to the supply or purchase order

before or after the supply has been executed, shall be referred to "The Secretary, Cricket Association of Uttarakhand, Dehradun", who may decide the matter himself.

- 10. All rates mentioned must be exclusive of any taxes and charges. Taxes and additional service charges by whatever name called, should be mentioned separately. The rates submitted shall be subject to negotiations (if needed be), once the eligible applicant/ Firm have been shortlisted and called for discussion by the Cricket Association of Uttarakhand (CAU)
- 11. GST Amount on invoice will be paid only after presentation of GST Challan deposited by the Agency/ Vendor concern.
- 12. The rates quoted by the party shall be firm during the currency of contract. All rates shall be written both in figures and in words. In case of discrepancy between the words and figures, rates indicated in words shall prevail.
- 13. CAU is at liberty to have more than one Transporter/ Agencies empaneled and the booking to any of the empaneled Transporter will be sole discretion of CAU.
- 14. Due to some unavoidable circumstances, if the booking is to be cancelled, then no cancellation charges should be applicable.
- 15. This document and services hereunder shall be governed by and construed and enforced in accordance with the Laws of India and in Dehradun jurisdiction only for any dispute arising out of as in relation to this proposal.
- 16. The kilometer mileage for the purpose of Vehicle run and hours of duty shall be reckoned from point of reporting for duty to the point of vehicle released. No mileage will be allowed to drivers for lunch/Breakfast or for the fuel etc.
- 17. In case the reporting/ release point is other than CAU designated point, distance from that point to the reporting / release point at actual Kilometer and actual time in hours will be considered.
- 18. The deployment of vehicle shall be punctual always. Late reporting and absence will attract penalty at the discretion of CAU.
- 19. Duties and responsibilities of the driver:
  - a) The drivers must observe all the etiquette and protocol while performing the duty.
  - b) While on duty to pick-up guests from Railway station / Bus stand / Airport, the driver should display the placard at the EXIT or suitable location for welcoming the passenger.
  - c) The Driver shall abide by all the Traffic Rules and Regulations in force, any penalties / disciplinary actions by authorities will be to the account of the transporter only.
- 20. The driver has to ensure proper filling and acknowledgement of Trip sheet booklet/ Duty Slip for each of the vehicle while performing the duty. The trip sheet details as recorded and signed will be the basis for preparing the bills.
- 21. The contractors shall make their own arrangement for parking the vehicles overnight and during off days and holidays.
- 22. All the offers received will be scrutinized and only technically qualified offers will

be considered for financial proposal opening. The Technically unqualified offers will be rejected.

- 23. CAU will inspect the fleet of the empaneled Companies/ Agencies. CAU may carryout inspection from time to time during subsistence of agreement.
- 24. In any case, if the Company/ Agency fails to provide service on requested date than the amount against making the alternative arrangement will be deducted from the Company account.
